This Twelfth Amendment to Oregon Health Authority 2013-2015 Intergovernmental Agreement for the Financing of Community Addictions and Mental Health Services dated as of July 1, 2013(as amended, the "Agreement"), is entered into, as of the date of the last signature hereto, by and between the State of Oregon acting by and through its Oregon Health Authority ("OHA") and Yamhill County ("County").

RECITALS

WHEREAS, OHA and County wish to modify the Financial Assistance Award set forth in Exhibit D-1 of the Agreement.

NOW, THEREFORE, in consideration of the premises, covenants and agreements contained herein and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

AGREEMENT

1. The financial and service information in the Financial Assistance Award are hereby amended as described in Exhibit 1 attached hereto and incorporated herein by this reference. Exhibit 1 must be read in conjunction with the portion of Exhibit D-1 of the Agreement that describes the effect of an amendment of the financial and service information.

REASON FOR FAAA (for information only):

Funds and CSDs are removed from A&D 61A and replaced at increased rate as non-ITRS bed days. Adult A&D Residential (A&D 61) client service day rate is increased effective July 1, 2013. Residential capacity (A&D 67) daily rate is increased to \$24 per CSD for the adult residential indigent and Medicaid-eligible bed days effective January 1, 2014. Housing for Dependent Children (A&D 62) is removed as ITRS and replaced as regular CSDs with a rate increase effective July 1, 2013. Additionally, A&D 61 and A&D 62 bed days are added for the 2014-15 fiscal year.

The following special condition(s) apply to funds as indicated by the special condition number in column 9. Each special condition set forth below may be qualified by a full description in the Financial Assistance Award.

- A0074 1 Special Condition A0001-3, regarding "ITRS (61A) rate" applies.
- A0074 2 The rate for A&D 61 is \$100 per CSD (Client Service Day) with total financial assistance not to exceed the total amount awarded on this line.
- A0074 3 This special condition replaces the rate portion of special condition A0001-2 as follows: The rate for A&D 61 is \$100 per CSD (Client Service Day).
- A0074 4 Special Condition A0001-5, regarding "ITRS A&D 62 rate" applies.
- A0074 5 The rate for A&D 62 is \$43.80 per CSD (Client Service Day) with total financial assistance not to exceed the total amount awarded on this line.
- A0074 6 This special condition replaces the rate portion of special condition A0001-4 as follows: The rate for A&D 62 is \$43.80 per CSD (Client Service Day).
- A0074 7 A) The financial assistance awarded for Service Element A&D 67 will be disbursed in substantially equal semiannual allotments. B) This special condition replaces the rate portion of special condition A0067-1 in Amendment 4 as follows: These allotments are for A&D 67 services at the rate of \$24 per CSD.
