Re: Sheriff Crabtree Glock model 23 service weapon

Captain Svenson,

I currently maintain Sheriff's Office inventory of (10) Glock model G23's compacts for use by Administration, Detectives and Special Investigations. (8) are currently assigned, and (2) are maintained as inventory spares. The Sheriff's current issued duty weapon is a Generation III model G23 with serial # KDU692 and is approximately 2004-2006 vintage. The newest model G23 maintained in inventory spares is a Generation IV weapon with serial # PUB808 and is several years newer.

As a practice, when new guns are purchased they are bought from the Glock law enforcement dealer located in Oregon. At the time of a new gun purchase generally old guns are traded towards the purchase of new. The most recent value of a traded gun (Jan 2014) was approximately \$289.00 for a non-compact Glock model G22. We did not buy nor did we trade any model Glock G23's in 2014.

Currently new gun law enforcement pricing for a Glock model G23 is approximately \$420.00. We maintain several newer Glock model G23's and declaring Glock model G23, serial # KDU692 as surplus is acceptable both from an inventory and financial perspective.
