THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (“the Board”) sat for the transaction of county business in formal session on January 15, 2015, Commissioners Allen Springer, Mary Starrett, and Stan Primozych being present.

THE BOARD MAKES THE FOLLOWING FINDINGS:

- A. The county “Supervisory Authority” is empowered by ORS 137.124, 144.085, 423.478 and ORS Chapter 144 to be responsible for critical decisions regarding parole and post-prison supervision. Under ORS 144.087, the “Supervisory Authority” is the “state of local corrections agency or official designated in each county by that county’s board of county commissioners or county court to operate corrections supervision services, custodial facilities or both.”
- B. Ted Smietana was designated Co-Supervisory Authority along with Sheriff Jack Crabtree on July 30, 2008 pursuant to Board Order 08-519.
- C. Sheriff Jack Crabtree retired as Yamhill County Sheriff on December 31, 2014. Sheriff Tim Svenson was sworn in on January 5, 2015. It is appropriate to designate Ted Smietana as Co-Supervisory Authority for Corrections Supervision Services along with Sheriff Tim Svenson, the keeper of the local correctional facility under ORS Chapter 169.

NOW, THEREFORE,

IT IS HEREBY ORDERED BY THE BOARD as follows:

- 1. Sheriff Tim Svenson and Ted Smietana are designated as “Co-Supervisory Authority” for purposes of ORS 137.124, 144.085, 423.478 and ORS Chapter 144 to operate corrections supervision services and custodial facilities.

2. Board Order 08-519 is repealed.






