SUBJECT: Roller Purchase

Public Works is requesting to purchase one used roller/compactor. This compactor will be used for gravel road maintenance and other road improvement projects. Funds for this purchase were budgeted in the 13/14 fiscal year although no purchase was made. The funds budgeted in 13/14 were transferred to the replacement fund for the future purchase when a suitable used machine was found.

We contacted several local area equipment dealers and searched various equipment trader websites for a good used machine. The national average asking price for this type and size of machine is \$63,500.00. A new machine is \$109,000.00 and monthly rental is over \$5,000.00.

Peterson Caterpillar of Portland offers a 2005 Caterpillar CS433E single drum roller with 1,141 hours for \$42,310.00. We tested this machine and found it to be in very good condition and meets our needs.

Other machines offered by Pape Machinery, Scott Equipment, and American Tractor ranged between \$49,500.00 and \$54,000.00.

Based on the above information I would like to recommend purchasing one used 2005 Caterpillar CS433E for \$42,310.00 from Peterson Caterpillar of Portland as offered. Peterson's offer is based on the National Joint Powers Alliance that we have been members of since 2007.
