### Life Jacket Kiosks at Rogers Landing

Please find attached some supplemental information, as requested, to follow up our meeting from last week in regards to putting a life jacket loaning kiosk at Rogers Landing in Newberg.

To reiterate: we have met with Parks Director Brett Henry and have reached out to many other local agencies and organizations to garner current and commitments for continued support in building, stocking and maintaining this life-saving project including the Oregon State Police, Oregon State Marine Board, Safe Kids Oregon and many others locally.

As you know, we're burning up summer as we speak. We understand this needs to be a thoughtful process and are aware of the many other projects you are managing. It is our sincere hope we've done enough of the legwork on this to make it easy to approve as quickly as possible so Donny can stop worrying about hearing another drowning call on the scanner. We don't want to get ahead of ourselves prior to getting the green light from you, but are eager to start collecting more jackets and getting going on construction.

This project is being organized by a group of committed volunteers earnestly hoping to work with you to create a successful county-community project which will aide first responders in keeping our citizens safe. Many of us working on this project call Newberg our hometown and we intend to make this something our community, and those who share it, can be proud of.

As we discussed, we can provide all the life vests in the world, and that won't save the life of someone who won't wear it. Given that, we feel a critical component of this project being successful is to commit to outreach and education on water safety and the importance of wearing life jackets. We have partnered with a young lady from Newberg High School who will be taking this on as her senior project. In addition, local agencies will work with us on this effort.

Finally, we intend for this to serve as a memorial to Cesar Campunzo a well loved and respected young man in our community who lost his life at Rogers Landing at the age of 15. We have reached out to his family and teachers who are also supportive and willing to help make this project successful.

Our contractor is Vaughn Lee with Above Board, based in Newberg. Lee is a fourth generation contractor and stated his goal for our kiosk at Rogers Landing to be an exemplary one statewide. In addition to being attractive, it will, of course, be structurally sound. Above Board is donating all the time and material it takes, in addition to donations gratefully accepted.

As it will be outdoors, we are planning to paint it with a high-quality outdoor paint to make it easy to repaint as weather conditions and potential vandalism create a need to do so.

We have selected colors that will be attractive, yet allow the structure to blend into its natural surroundings.  
We will place 6x6 posts in gravel rather than concrete.

In regards to signage:

The signage will be basic - illustrations of how to properly fit a life vest, using pictorial graphics.

We recommend that county counsel confers with Washington County's counsel to determine what, if any, additional wording the county would like us to place on the sign. We have found no case history of this being a liability issue, but understand the need to be cautious.

In addition to your recommendation, we were planning to post:  
Life Jackets Save Lives. Use at your own risk.

\*We have done an initial inquiry regarding getting a permit, if it is required we will certainly pull one immediately upon your approval of his proposal.




Proposed location sketch:

\*Reminder that Parks Director Brett Henry recommended putting it up near the bathrooms which would allow for better security. However, after consulting and carefully considering the suggestion we respectfully ask for it to be placed in the most natural place for those targeted in this safety campaign: those walking down the trail to the swimming hole. We believe people are creatures of habit and often take the path of least resistance. This location would make it impossible to avoid the signage and imagery reminding them to wear life jackets. Then, on the way back out of the river it would be harder to forget to return them.





A close up of the proposed area sketch:




