Hi Mary and Laura,

The attached Service Element Prior Authorizations (SEPA's) contain initial funding allocations to our Intergovernmental Agreement #148087 (BO 15-297) with the Department of Human Services for our Developmental Disabilities program for the 2015-2017 biennium for the service elements listed below. The "Special Projects" funds are tied to our agreement with Nursingale to provide direct nursing services to a designated client based on the client's annual plan. As in prior biennia, the Family Support funding is state general fund that can be used for certain services focused on children. Since the advent of Oregon's Community First Choice (K-Plan) Medicaid program which offers more service availability for children who qualify, the focus of the Family Support funding is more toward children who do not qualify or do not yet qualify for Medicaid services. The amount and type of services available in this general fund program is more limited than that available through K-Plan. It's also worth noting that both cannot be delivered concurrently. These amounts are included in our Health and Human Services 2015-2016 Adopted Budget.
