GRANT AGREEMENT

Mid-Valley Behavioral Care Network and Yamhill County

Mid-Valley Behavioral Care Network (MVBCN), acting on behalf of the Mid-Willamette Valley Acute Care Region (MWVACR), provides a grant of \$530,636 to Yamhill County for the purpose described in Section 2. Yamhill County agrees to use these funds solely for the purpose(s) described. Funds not used for these purposes shall be returned if requested with cause if such request is made by either Marion or Benton Counties or if required by the Oregon Health Authority retroactively through Intergovernmental Agreements with Benton and Marion Counties.

1. By execution of this Agreement, Yamhill County certifies under penalty of perjury that:
 - a. To the best of Yamhill County's knowledge, Yamhill County is not in violation of any tax laws described in ORS 305.380(4); and
 - b. Yamhill County has not discriminated against minority, women or small business enterprises in obtaining any required subcontracts; and
 - c. Yamhill County agrees to comply with federal and state laws and regulations.

2. Purpose of the grant:
 - a. Yamhill County will utilize these funds for the following:
 - i) Inpatient psychiatric services delivered to individuals who are suffering from an acute mental illness, or other emotional disturbance posing a danger to the health and safety of the individual or others.
 - ii) Services intended to stabilize, control, or ameliorate acute psychiatric dysfunctional symptoms or behaviors in order to return individuals to less restrictive environments at the earliest possible times.
 - iii) Ancillary services such as regional coordination and enhancement to Community Mental health Program services that serve to expedite the movement of individuals into and out of facilities where inpatient services are delivered and to divert persons from acute care services.

3. Payment method:
 - a. MVBCN will disburse \$530,636 following the execution of this Agreement.

4. Reporting:
 - a. Yamhill County will provide records to MVBCN upon request that include at minimum: the provision and outcomes of these services as well as a full and complete accounting for the funds received under this Agreement.
