Hi Mary and Laura,

Attached is a Service Element Prior Authorization (SEPA) which adds \$1,000,000 in funding for Long term support for kids programs to cover services authorized in Plans of Care effective July 1, 2015 through June 30, 2017.

This funding is paid directly to Personal Support Workers and Independent Contractors who provide services to individuals enrolled under Yamhill County's Developmental Disability program. As you may recall as a result of state plan changes, these services continue to grow and are having a very positive impact not only on improving the health and safety of our vulnerable population, but also creating some opportunities for them to gain skills toward greater independence. We also hear feedback that families are able to experience greater stability while caring for their family members at home. These services are providing proactive supports and avoiding the need for out of home placement.

I recommend the Board approve this SEPA. Please let me know if you have any questions.


