



Hi Mary and Laura,

The attached Service Element Prior Authorization (SEPA) increases the funding allocation by \$372,288 in our Intergovernmental Agreement with the Department of Human Services for our Developmental Disabilities program for Direct Nursing services effective March 1, 2016 through February 28, 2017. This amount is included in our Health and Human Services 2015-2016 Adopted budget.

The increased allocation continues direct nursing hours for one client enrolled in our In Home Comprehensive Services program based on the individual's plan of care. These funds are passed through the County for payment to the provider for direct nursing care.

I recommend the Board approve this SEPA. Please let me know if you have any questions.
