



Hi Mary and Laura,

The attached Service Element Prior Authorization (SEPA) increases the funding allocation to our Intergovernmental Agreement with the Department of Human Services for our Developmental Disabilities program for Family Support effective July 1, 2015 through June 30, 2017. The majority of these funds are paid through the Express Payment & Reporting System (eXPRS) and the increase is needed to allow for authorizations due to a technical issue with the processing of claims in eXPRS. A small amount of these funds are passed through to the County for purchases of items to assist the client or in care of the client and is included in our 2016-2017 Health and Human Services Adopted Budget.

Family Support funding is state general fund that can be used for certain services focused on children. Since the advent of Oregon's Community First Choice (K-Plan) Medicaid program which offers more service availability for children who qualify, the focus of the Family Support funding is more toward children who do not qualify or do not yet qualify for Medicaid services. The amount and type of services available in this general fund program is more limited than that available through K-Plan. It's also worth noting that both cannot be delivered concurrently. There were claims for 12 children during the 2015-2016 fiscal year totaling \$5,384.30.

I recommend the Board approve this SEPA as written.
