Hi Mary and Laura,

The attached Service Element Prior Authorization (SEPA) decreases the funding allocation by \$341,264 in our Intergovernmental Agreement with the Department of Human Services for our Developmental Disabilities program for Direct Nursing services effective April 1, 2016 through February 28, 2017.

The allocation is being decreased as the funds will no longer be passed through the County for payment to the provider using eXPRS (the Oregon Department of Human Services payment and reporting system). Effective April 1, 2016 the payments for these services are authorized and paid directly to the provider through the state Medicaid payment system.

I recommend the Board approve this SEPA. Please let me know if you have any questions.
