

MODIFICATION OF PHYSICIAN SERVICES AGREEMENT
(District Medical Examiner)
William J. Koenig, D.O.

THIS AGREEMENT is between Yamhill County, a political subdivision of the State of Oregon, acting by and through its Board of Commissioners, District Attorney and Public Health Division of its Department of Health and Human Services ("County"), and **WILLIAM J. KOENIG, D.O.** ("Physician"), Physicians' Medical Center, 2695 Tanger Drive, McMinnville, OR 97128.

RECITALS: Physician serves as a District Medical Examiner for County pursuant to a Physician Services Agreement made in 2003 and memorialized as Board Order 03-132 (the Underlying Agreement). The Underlying Agreement was first amended in 2006 (B.O. 06-229) and again in 2011 (B.O. 11-161). Physician and County now desire to further amend the Underlying Agreement as described herein. NOW, THEREFORE,

AGREEMENT: In exchange for the promises and other consideration as set forth below, it is hereby agreed between the parties that the Underlying Agreement is hereby modified as follows:

SECTION 1. New subsections 1.g. and 1.h. The following are added as new subsections 1.g. and 1.h:

- "g. To make a report of death investigation to the State Medical Examiner as soon as possible, but in no event later than 10 days unless there are unusual circumstances, after Physician has received notice of a death requiring investigation.
- h. To notify Community Mental Health Program (CMHP) director or designee of all suspected suicide completions within one business day of completion of a death investigation so that CMHP director or designee can do postvention activities within the community. Provide data needed to CMHP director or designee as required under 2015 Senate Bill 561 for persons 24 years of age or younger so that CMHP director or designee can complete report(s) to Oregon Health Authority."

SECTION 2. Section 2(1)(a) of the Underlying Agreement is hereby deleted in its entirety and replaced with the following language:

- "a. Beginning November 1, 2016 payment of \$1,500.00 per month shall be made to Physician. Compensation under this section shall constitute the total monthly payment for the duration of the agreement. The parties recognize there are two district medical examiners, and each are paid separately."

SECTION 3. The following language is hereby added to the end of existing section 3(2)(a) of the Underlying Agreement:

"Physician agrees that it has complied with the tax laws of the state of Oregon or a political subdivision of the state of Oregon, including ORS 305.620 and ORS Chapters 316, 317 and 318."

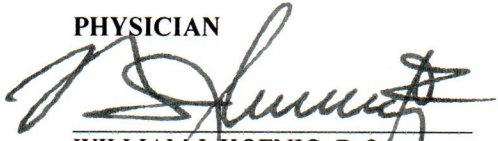
SECTION 4. No other changes. Except as provided above, the Underlying Agreement remains in full force and effect.

SECTION 5 Counterparts and facsimile signatures. The parties may execute this agreement in counterparts, each of which shall be deemed to be an original thereof. The parties agree that facsimile signatures shall be accepted as original signatures with respect to this agreement.

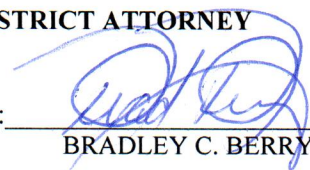
