

MEMORANDUM OF AGREEMENT

(Control Room Technician Classification Changed from Range 6 to Range 5)

THIS MEMORANDUM OF AGREEMENT is made a part of the 2016-2019 Collective Bargaining Agreement between Teamsters Local 223 ("the Union") and Yamhill County, a political subdivision of the State of Oregon acting by and through its Sheriff and Board of Commissioners ('the County').

RECITALS:

- A. On December 9, 2016 the County provided notice to the Union that, as part of ongoing efforts to restructure the provision of jail medical services, it would need to reclassify and reactivate the position of Control Room Technician (CRT) and deactivate the position of Medical Technician (Med Tech).
- B. The position of CRT and Med Tech shall both continue to be listed on the CLASSIFICATIONS & SALARY RANGES table of the collective bargaining agreement between the Union and the County. The CRT position has not been filled since the late 1990's when the Records Division was moved to the East end of the building and the position was no longer filled. Since that time, Records Clerks have completed the clerical portion of the CRT position and Deputies have completed the portion involved in running the Control Room.
- C. As part of the restructuring of the provision of jail medical services, the County proposes to (i) move two current employees from the position of Med Tech to the position of CRT, (ii) reclassify the CRT position from Range 6 to Range 5, and (iii) revise the CRT job description as provided herein.
- D. The Union is in agreement with the above described restructuring, the employment moves and is willing to accept the above described reclassification and revised job description.
NOW THEREFORE,

AGREEMENT: The County and the Union hereby agree as follows:


1. Reclassification of position. The CRT position will be reclassified from salary range 6 to salary range 5. The original CRT position also required performing certain Records Clerk duties which required LEDS certification and knowledge of many different complex items such as court judgments, sentence orders, setting up transports and numerous LEDS entries.
2. Job description. The CRT job description attached hereto as Exhibit A and incorporated herein by this reference has been revised to remove the Records Clerks functions. The new CRT job description will be issued prior to the new CRT position becoming available.

3. Medical Technicians. Current Med Tech staff will be offered positions as CRT's prior to the position being filled in any other manner.

a. Probationary term. If either Med Tech chooses to fill a CRT position they shall serve a probationary period in accordance with Section 16.2 of the 2016-2019 collective bargaining agreement between the Union and the County.
