Re: SWAC Position

Jennifer Redmond-Noble's term on the Yamhill County Solid Waste Advisory Committee (SWAC) will expire on March 27, 2017. Originally, Jennifer was asked to be a part of the committee due to the proximity of her home to Riverbend Landfill, and filling the position previously held by Jack Alin. Her knowledge of the area around Riverbend Landfill has helped the committee address concerns about the landfill, from a citizen's point of view. Her position on SWAC also fulfills a requirement of the Local Citizens Advisory Committee (LCAC) which was combined with the SWAC in 1992.

Ms. Redmond-Noble is willing to serve another three-year term on the SWAC. Staff recommends her reappointment based on her conscientious participation in the past.

The Board will decide whether to reappoint Jennifer Redmond-Noble for another three year term on the SWAC (staff's recommendation), or advertise the opening and interview applicants.
