

**AMENDMENT NO. 1 TO
PROFESSIONAL SERVICE AGREEMENT
(Sex Offender Treatment/Individual Therapy/
Group and Family Counseling)**

THIS AMENDMENT NO. 1 ("Amendment #1") shall be made effective as of July 1, 2017, by and between **Yamhill County**, a political subdivision of the State of Oregon, acting through the Juvenile Division of its Department of Community Justice ("DCJ") and **Higher Ground Counseling, Inc.**, an Oregon corporation, located at 2505 Portland Road, Suite 202B, Newberg, Oregon, 97132 ("Contractor").

RECITALS

A. County and Contractor are parties to that certain contract dated December 13, 2016 (the "Underlying Contract"), pursuant to which Contractor provides County with sex offender treatment services, as further described in the Underlying Contract. The Underlying Contract is memorialized in Yamhill County records as Board Order 16-482.

B. County and Contractor now desires to modify the Underlying Contract upon the terms and conditions more particularly set forth herein below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein below and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Section 1 of the Underlying Contract is hereby amended to extend the Underlying Contract from July 1, 2017 through June 30, 2018, unless terminated in accordance with Section 5 of the Underlying Agreement.

The balance of Section 1 remains unchanged.

2. Section 2 of the Underlying Contract is hereby amended to include the following services:
"Consultation: Contractor agrees to provide professional consultation (in person or over the phone) as requested, including but not limited to: (i) special team meetings, and (ii) report/safety plan writing."

3. Section 4 of the Underlying Contract is hereby amended to read as follows:

"County agrees to pay Contractor for the services provided under this Agreement at the rate of \$100.00 per hour for individual/family therapy, \$50.00 per hour for each individual participating in a group therapy session and \$50.00 per hour for Consultation services. No minimum number of hours is guaranteed by this Agreement, The maximum amount to which the County is obligated to pay under this Agreement is \$10,000. County shall make payment to Contractor no later than the 30th day of the month following receipt, review and approval of an itemized statement for services provided the preceding month.

4. Ratification. Except as otherwise expressly modified by the terms of this Amendment #1, the Underlying Contract shall remain unchanged and continue in full force and effect. All terms, covenants and conditions of the Underlying Contract not expressly modified herein are hereby confirmed and ratified

and remain in full force and effect, and constitute valid and binding obligations of County and Contractor enforceable according to the terms thereof.

5. Authority. County and Contractor and each of the persons executing this Amendment #1 on behalf of County and Contractor hereby covenants and warrants that: (i) such party has full right and authority to enter into this Amendment #1 and has taken all action required to authorize such party (and each person executing this Amendment #1 on behalf of such party) to enter into this Amendment #1, and (ii) the person signing on behalf of such party is authorized to do so on behalf of such entity.

6. Binding Effect. All of the covenants contained in this Amendment #1 shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, legal representatives and permitted successors and assigns.


7. Counterparts. This Amendment #1 may be executed in multiple counterparts, each of which shall be an original, but all of which shall constitute one and the same Amendment #1.


