

**AMENDMENT NO. 1 TO
CONTRACT EMPLOYEE AGREEMENT
Yamhill County and Jennethan Mayo
(Ascend and ProVal Support Services)**

THIS AMENDMENT NO. 1 ("Amendment #1") shall be made effective as of June 8, 2017, by and between **Yamhill County**, a political subdivision of the State of Oregon, acting by and through its Board of Commissioners ("County") and Jennethan Mayo, an individual, 615 SE Centurian Ave., Gresham, OR 97080 ("Employee")

RECITALS

A. County and Employee are parties to that certain contract dated April 6, 2017 (the "Underlying Contract"), pursuant to which Employee provides County with professional management consulting services in the area of property valuation and taxation, in particular assisting County with the implementation of Ascend and ProVal tax software. The Underlying Contract is memorialized in Yamhill County records as Board Order 17-115.

B. County and Employee now desires to modify the Underlying Contract upon the terms and conditions more particularly set forth herein below.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein below and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Section 2 of the Underlying Contract is hereby amended to include the following Obligations of County:

"8. To pay up to a maximum not to exceed amount of \$3,000 for actual incurred travel and lodging related expenses, subject to prior review and approval by County Assessor and County Administrator.

The balance of Section 2 remains unchanged.

2. Ratification. Except as otherwise expressly modified by the terms of this Amendment #1, the Underlying Contract shall remain unchanged and continue in full force and effect. All terms, covenants and conditions of the Underlying Contract not expressly modified herein are hereby confirmed and ratified and remain in full force and effect, and constitute valid and binding obligations of County and Employee enforceable according to the terms thereof.

3. Authority. County and Employee and each of the persons executing this Amendment #1 on behalf of County and Employee hereby covenants and warrants that: (i) such party has full right and authority to enter into this Amendment #1 and has taken all action required to authorize such party (and each person executing this Amendment #1 on behalf of such party) to enter into this Amendment #1, and (ii) the person signing on behalf of such party is authorized to do so on behalf of such entity.

4. Binding Effect. All of the covenants contained in this Amendment #1 shall be binding upon and shall inure to the benefit of the parties hereto and their respective heirs, legal representatives and permitted successors and assigns.

5. Counterparts. This Amendment #1 may be executed in multiple counterparts, each of which shall be an original, but all of which shall constitute one and the same Amendment #1.


