SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in informal/formal session on November 21, 2017, at 2:00 p.m. in the Commissioners' Office Conference Room, Commissioners Stan Primozych and Richard L. "Rick" Olson being present with Commissioner Mary Starrett being excused.

Commissioner Primozych called the meeting to order at 2:00 p.m.

4. **B.O. 17-478** - Consideration of approval of Amendment #2 to Agreement #153142 (B.O. 17-207) between Yamhill County and the Oregon Health Authority (OHA) for the financing of community mental health, substance use disorders, and problem gambling services, in the amount of \$129,120, retroactive to July 1, 2017 through June 30, 2019.

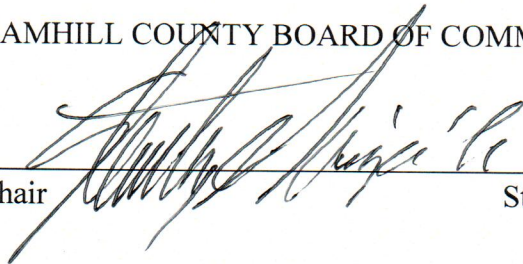

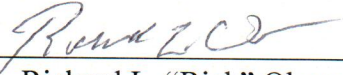
