THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in informal/formal session on July 2, 2019, at 1:30 p.m. in Room 32 of the courthouse, Commissioners Richard L. "Rick" Olson, Mary Starrett, and Casey Kulla being present.

Also present were Ken Huffer, County Administrator; Justin Hogue, Business Services Director; Christian Boenisch, County Counsel; Nicole Montesano, News-Register; and others as listed on the sign-in sheet.

6. **B.O. 19-239** - Consideration of the appointment of YCEA members James Craver, Elsa Pantoja and Emilia Barragan and management representatives Jessica Beach, Ken Friday and Silas Halloran-Steiner to the Yamhill County Classification Committee, each for a three-year term to expire on July 2, 2022.

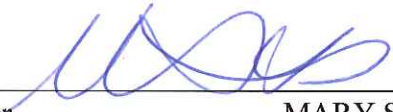
