2. **B.O. 19-500** - Approval of grant agreement #33897 between Yamhill County and the State of Oregon Department of Transportation, Rail and Public Transit Division to purchase two Category A buses and one Category E minivan in the grant amount of \$707,072 with match funds, effective November 1, 2019 through December 31, 2021.
3. **B.O. 19-501** - Authorize county counsel and transit manager to procure an agreement with Connexionz, LTD. for the purchase and installation of smart bus technology hardware on four buses.

1. **B.O. 19-512** - Consideration of authorizing a notice of intent to award a contract to Farline Bridge, Inc. for the Yamhelas Westsider Trail (Phase 2) Construction Project in the amount of \$564,812.

Mr. Huffer noted the notice of intent is part of the grant process to begin contract negotiations. Farline Bridge, Inc. has been used for several previous county projects. Commissioner Starrett expressed her opposition. Commissioner Kulla moved approval of item F1. The motion passed, Commissioners Olson and Kulla voting aye, Commissioner Starrett voting nay.

2. **B.O. 19-513** - Consideration of approval of Amendment #9 to the extend the delegation agreement between Yamhill County and Yamhill County Care Organization (B.O. 14-706), effective January 1, 2020 through December 31, 2020.

Commissioner Starrett moved approval of item F2, subject to the final approval by county counsel. The motion passed, Commissioners Olson, Starrett and Kulla voting aye.

3. **B.O. 19-514** - Consideration of approval of the agreement between Yamhill County and Yamhill County Care Organization to replace the agreement under B.O. 12-476, effective January 1, 2020 through December 31, 2020.

Commissioner Kulla moved approval of item F3, subject to the final approval by county counsel. The motion passed, Commissioners Olson, Starrett and Kulla voting aye.

4. **B.O. 19-515** - Consideration of approval of the agreement between Yamhill County and Yamhill County Care Organization for administrative services, effective January 1, 2020 through December 31, 2020.

Commissioner Starrett moved approval of item F4, subject to the final approval by county counsel. The motion passed, Commissioners Olson, Starrett and Kulla voting aye.

5. **B.O. 19-516** - Consideration of approval of the provider agreement between Yamhill County and Yamhill County Care Organization for safety net services, effective January 1, 2020 through December 31, 2020.

Commissioner Kulla moved approval of item F5, subject to the final approval by county counsel. The motion passed, Commissioners Olson, Starrett and Kulla voting aye.



6. **B.O. 19-517** - Consideration of an order establishing a public hearing date and time to consider the vacation of a segment of Old Station Road, County Road #438 at the request of Dan Ramsey, Public Works Docket #RV-4-19.

Todd Sadlo stated this order is to set a public hearing because of an objection to the road vacation. Bill Gille clarified the issue, which is a lack of easement to get to the turnaround once the road is closed. Mr. Sadlo does not recommend a conditional road vacation. He recommends adopting the ordinance to set the public hearing for January 23, 2020 in Room 32 of the courthouse.

Commissioner Starrett moved approval of item F6 as recommended by county counsel. The motion passed, Commissioners Olson, Starrett and Kulla voting aye.

7. **B.O. 19-518** - Consideration of the following appointments to the Mid-Willamette Valley Area Commission on Transportation Committee (MWACT) to serve a 2-year term to expire December 2021:

Commissioner Starrett moved approval of item F7. The motion passed, Commissioners Olson, Starrett and Kulla voting aye.
