THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in formal session on January 30, 2020 at 10:00 a.m. in Room 32 of the courthouse, Commissioners Casey Kulla and Richard L. "Rick" Olson being present. Commissioner Mary Starrett was excused.

A. CALL TO ORDER

Commissioner Kulla called the meeting to order at 10:00 a.m.

B. FLAG SALUTE

C. PUBLIC COMMENT: This time period is reserved for public comment on any topic other than: 1) agenda items, 2) A quasi-judicial land use matter, or 3) a topic scheduled for public hearing. The Chair may limit the length of individual comments.

There was no public comment.

D. CONSENT AGENDA: Commissioner Olson moved approval of items D1 through D3. The motion passed, Commissioners Kulla and Olson voting aye.

1. **B.O. 20-32** - Approval of the following reappointments to the Public Health Board of Health, terms to expire February 1, 2024: Trevallee, Marie Schoof, Tami Tigner, Raji Matthews and Jennifer Goodman.

2. **B.O. 20-33** - Approval to authorize twenty-nine (29) days of leave without pay for employee #3452, effective January 17, 2020 with an anticipated end date of February 28, 2020.

3. **B.O. 20-34** - Approval of submitting a letter of support for HB 4112.

E. OLD BUSINESS:

1. Consideration of the adoption of written findings and conditions of Docket #SDR-28-19: An appeal of the Planning Commission's approval of a site design review for a recreational marijuana and industrial hemp processing facility. Applicant: OreTexFarms, LLC., JCB Farms, LLC. and Christopher Bryan (as agent for the owner, WAG Holdings, LLC.). Location: 18505 NE Jaquith Rd., Newberg. Appellants: Laura Cochran and Jill Anderson. *[Decision to uphold the Planning Commission's approval and to approve the application was made January 16, 2020].*

Todd Sadlo stated the findings are not ready for adoption but would be ready for adoption on February 13, 2020. No action was taken.

1. **B.O. 20-35** - Consideration of adopting Resolution 20-01-30-1 proclaiming the month of February as The Melt Down Grilled Cheese Sandwich Month.

Commissioner Olson moved approval of item F1. Commissioner Kulla read Resolution 20-01-30-1 into the record. The motion passed, Commissioners Kulla and Olson voting aye.
