Re: Transition from .40 caliber to 9 mm issued duty weapons – Request for Surplus Designation

In November 2019, B.O. 19-452 approved the expenditure to purchase new Glock 17s and 19s 9 mm handguns to replace the Glock .40 caliber handguns as issued duty weapons. This transition is expected to provide a more efficient and effective piece of equipment for staff and bring long-term savings to the Office due to improvements in firearms technology.

Below are the current Glock 22s and 23s that we are requesting to be surplus; as previously discussed, these surplus weapons will be sold to staff or resold to a third-party firearms dealer at the fair market value resale set price. Those listed in italics are those acquired from the City of Amity when we took over the police services contract there.
