THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (“the Board”) sat for the transaction of county business in formal session on December 17, 2020, Commissioners Casey Kulla, Mary Starrett and Richard L “Rick“ Olson being present.

**WHEREAS**, on March 17, 2020 the Yamhill County Board of Commissioners (“Board”) formally declared a State of Emergency within Yamhill County to address the continued spread of COVID-19, memorialized as Board Order 20-93 and Resolution 20-03-17-1 (the “Declaration”); and

**WHEREAS**, on March 26, 2020 the Board formally extended the Declaration through June 30, 2020, unless extended or earlier terminated by the Board, memorialized as Board Order 20-105 and Resolution 20-03-26-1; and

**WHEREAS**, on June 25, 2020 the Board formally extended the Declaration again through July 31, 2020, unless extended or earlier terminated by the Board, memorialized as Board Order 20-205 and Resolution 20-06-25-2; and

**WHEREAS**, on July 30, 2020 the Board formally extended the Declaration again through September 30, 2020, unless extended or earlier terminated by the Board, memorialized as Board Order 20-257 and Resolution 20-07-31-1; and

**WHEREAS**, on September 24, 2020 the Board formally extended the Declaration again through October 30, 2020, unless extended or earlier termination by the Board, memorialized as Board Order 20-338 and Resolution 20-09-24-2

**WHEREAS**, on October 22, 2020 the Board formally extended the Declaration again through December 31, 2020, unless extended or earlier termination by the Board, memorialized as Board Order 20-376 and Resolution 20-10-22-1

WHEREAS, the spread of COVID-19 continues to affect all of Yamhill County and the Board has determined that continued measures in the form of a further extension of the Declaration is needed; NOW THEREFORE

IT IS HEREBY ORDERED AND RESOLVED BY THE BOARD AS FOLLOWS:
