SITTING FOR THE TRANSACTION OF COUNTY BUSINESS

THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY (“the Board”) sat for the transaction of county business in combined session on December 2, 2021, at 10:00 a.m. in a virtual meeting via Zoom, Commissioners Mary Starrett, Lindsay Berschauer and Casey Kulla being present.

Also present were Ken Huffer, County Administrator; Christian Boenisch, County Counsel; Tim Svenson, Sheriff; Nohely Barajas-Montalvo, Legal Assistant; Patty Sauer, YCOM; and Jason Foose, County Surveyor.

**A. CALL TO ORDER:** Commissioner Starrett called the meeting to order at 10:04 a.m.

1. Work Session #1 –

a. Review/discussion of Radio System Review.

Sheriff Svenson, and Chad Lund and Scott Reilly of Communications Northwest presented an annual radio system assessment with system improvement recommendations. Sheriff Svenson stated he will provide a recommendation to the Board for further discussion. There was no action taken.

2. Work Session #2 –

a. Review/discussion of Economic Development Services with SEDCOR

Abisha Stone and Erik Andersson presented SEDCOR's scope of work summary recapping services to the county between 2018 – 2021 and discussed the annual contract renewal. After discussion, the consensus of the Board was to direct staff to negotiate a six-month contract extension with SEDCOR. There was no action taken.

Commissioner Starrett moved approval of item II. The motion passed, Commissioners Starrett, Berschauer and Kulla voting aye.

2. Discussion regarding Strategic Planning Session and Communications Policy.  
(Commissioner Berschauer).

Commissioner Berschauer addressed potential modifications to top-tier administration functions and implementation of a communications strategy. After discussion, the consensus of the Board was for Commissioner Berschauer to coordinate with Mr. Huffer to outline a proposal. There was no action taken.

3. Discussion regarding the notice of proposed rulemaking on Oregon Administrative Rules (OAR) 333-019-0010 and 333-019-1005. (Commissioner Starrett).

Commissioner Starrett addressed requesting an extension to provide public comment regarding OAR's related to digital vaccination. There was no action taken.


