



**ADDENDUM TO COMMUNICATION SERVICES AGREEMENT**

This Addendum to the Communication Services Agreement is made and entered into as of 3/15/2022 | 1:36 PM CDT and between **Stericycle Communication Solutions, Inc.** (hereinafter referred to as "Stericycle") and **Yamhill county Health and Human Services** (hereinafter referred to as "CLIENT") with reference to the following:

- Stericycle and CLIENT are parties to an original Communication Services Agreement dated as of **November 7, 2014** (collectively the "Existing Agreement");
- A. Client desires to contract with Stericycle to establish terms and conditions under which facilities that elect to participate in the Existing Agreement may obtain Services from Stericycle, and Stericycle desires to perform the Services for Client and Client Participating Facilities. A participating facility ("Participating Facility") is any facility owned, operated, leased, or joint ventured in any capacity with Client. The existing Participating Facilities are listed in the Existing Agreement. Additional Participating Facilities may be added to the Existing Agreement upon execution of a separate Addendum;
- B. Stericycle and CLIENT now desire to add the New Participating Facilities (the "**New Participating Facilities**") listed in the table below as new Participating Facilities to the Existing Agreement;
- C. All terms and conditions of the Existing Agreement shall remain in full force and effect with the exception of the sections listed below:

**SERVICES TO BE PROVIDED**

Stericycle shall provide **Patient Prompt** to the **New Participating Facilities** as described in the Existing Agreement.

Stericycle shall provide **Patient Prompt** to twenty-two (22) new providers.

**FEES**

- a. Patient Prompt: The **New Participating Facilities** shall pay to Stericycle the fees as set forth in the Pricing Schedule, attached hereto as **Exhibit A**.
- b. All other rates, terms, and conditions described in the Existing Agreement shall apply to the **New Participating Facilities**.

**CONTRACT EXECUTION**

All terms and conditions of this Addendum shall be deemed null and void if this Agreement is not fully executed by the last day of **March, 2022**.
