Hi Mary and Ken,

Attached is amendment #2 to our agreement with the Oregon Health Authority for the financing of Community Mental Health, Addiction Treatment, Recovery, & Prevention, and Problem Gambling Services (BO 21-490). The amendment adds \$261,881.05 in funding for Mobile Crisis Services retroactive to January 1, 2022 through December 31, 2022. While this funding is not specifically included in our Health and Human Services 2021-2022 Adopted Budget we have sufficient budget authority.

The funds were appropriated under HB 2417 to Community Mental Health Programs to establish/expand mobile crisis services. The additional funds will allow us to add additional members to our mobile crisis team to respond to the needs of our community members 24 hours per day, 7 days per week.

Pursuant to the addition of this new revenue, we request board consideration to change current position management authority within our HHS Adult Behavioral Health Division (Div 174) as follows:

- Add 3.0 full-time equivalent (FTE) of HS Specialist III (406.24).

I recommend approval of this amendment as written. Please let me know if you have any questions.
