THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in combined session on September 8, 2022, at 10:00 a.m. in Room 32 of the courthouse and a virtual meeting via Zoom, Commissioners Lindsay Berschauer, Casey Kulla and Mary Starrett being present.

Also present were Ken Huffer, County Administrator; Christian Boenisch, County Counsel; Carolina Rook, BOC Staff; Jessica Beach, Director of Community Justice; Nohley Barajas-Montalvo, Legal Assistant.

Commissioner Kulla moved approval of item H1. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

I. OTHER BUSINESS (Add-ons and non-consent items):

1. B.O. 22-281 - Consideration of approval of a contract employment agreement between Yamhill County and Christina Ferguson for administrative services in the amount of \$74.74 per hour, not to exceed 15 hours per week effective September 16, 2022, through June 30, 2023 with automatic renewal.

Commissioner Berschauer moved approval of item I1. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

2. **B.O. 22-282** - Consideration of approval to submit an application for the FY2022-23 Emergency Management Performance Grant (EMPG), retroactive to September 4, 2022.

Commissioner Berschauer moved approval of item I2. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

3. **B.O. 22-283** - Consideration of approval of a contract employment agreement between Yamhill County Sheriff's Office and Rodney S. Dunham to provide pre-employment background investigation services in the amount of \$45.00 per hour, retroactive to August 24, 2022, through June 30, 2023 with automatic renewal.

Commissioner Kulla moved approval of item I3. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

4. **B.O. 22-284** - Consideration of approval of a contract employment agreement between Yamhill County Sheriff's Office and William "Mike" Browne to provide pre-employment background investigation services in the amount of \$45.00 per hour, retroactive to August 24, 2022, through June 30, 2023 with automatic renewal.

Commissioner Kulla moved approval of item I4. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

5. **B.O. 22-285** - Consideration of approval of a quote and contract between Yamhill County Health and Human Services and Zoom Video Communications for telemedicine and group meetings in the amount of \$168,070 effective upon approval for three years.

Commissioner Starrett moved approval of item I5. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

6. Consideration of Secure Rural Schools and Community Self Determination Act (SRS) County Allocation.

Ken Huffer explained that this item did not require a Board action but he requested a consensus from the Board to determine allocation of the USDA funding. He recommended continuing the 85% - 15% split between roads/schools and Title II to which the Board was in consensus to maintain. There was no action taken.

7. **B.O. 22-286** - Consideration of approval in the matter of an order vacating a portion of a public road at the request of Lea J. Gillette and Alban H. Debeaulieu without a public hearing, Public Works Docket # RV-2-2022.

Commissioner Berschauer moved approval of item I7. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

8. **B.O. 22-287** - Consideration of approval in the matter of an order vacating a portion of a public road at the request of Stephen A. Walker and Mary L. Walker without a public hearing, Public Works Docket # RV-4-2022.

Commissioner Kulla moved approval of item I8. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

9. **B.O. 22-288** - Consideration of approval to submit a grant application for the Criminal Justice Commission Justice Reinvestment (JRI) Capacity Building Grant.

Jessica Beach provided clarification on the amount set aside for this program and the intent to assist with local jurisdictions. She explained how the money is distributed and what organizations it assists. Commissioner Berschauer moved approval of item I9. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.

10. Discussion regarding ballot measure to create a new fire district combining the current City of McMinnville and McMinnville Rural service areas. (Commissioner Berschauer).

Christian Boenisch stated the City of McMinnville has asked to move forward on the district formation process; he outlined the Board's role to initiate the formation process in combination with a required resolution by the city to be placed on the ballot in May 2023. Ken Huffer added that an agreement would be negotiated with the city to recoup any associated costs incurred by the county. After discussion, the consensus of the Board was to go forward with the resolution to be placed on the ballot in May 2023. There was no action taken.

11. Discussion of Commercial Property Assessed Clean Energy (C-PACE) Program.

Commissioner Berschauer summarized that this program has been adopted by the state and that staff is looking to other counties to see how this has been implemented. Commissioner Starrett shared her concern of the workload that would be put onto staff. Abisha Stone of SEDCOR joined the conversation and provided clarification that C-PACE includes projects that could benefit from access to the private funding of borrowed capital. She explained the reason the county would require adoption of an ordinance for this process due to a process required through the Assessor's office. She detailed the Board's options to consider and explained the lien process for the program. There was question and discussion as to why it needs to be through Ordinance with the County. Ken Huffer clarified what he needs direction on from the Board and that he believes the county has the resources to do this but just needs to know if there is consensus from the Board to continue forward and working towards administering this program. After further discussion, it was the consensus of the Board to invite those who can answer the Board's more technical questions and provide a summary of how the program works during formal session on October 6th.

12. **B.O. 22-289** – Consideration of approval of the HB 4004 Workforce Stability Grant Plan.

Ken Huffer provided an update on his discussions with the AFSCME Union related to HB 4004. Mr. Huffer explained the process for fund distribution within this fiscal year.

Commissioner Berschauer moved approval of item I12. The motion passed, Commissioners Berschauer, Kulla, and Starrett voting aye.
