THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY ("the Board") sat for the transaction of county business in combined session on March 23, 2023, at 10:00 a.m. in a virtual meeting via Zoom, Commissioners Lindsay Berschauer, Kit Johnston and Mary Starrett being present.

Also present were Ken Huffer, County Administrator; Christian Boenisch, County Counsel; Jodi Gollehon, Assistant County Counsel II; Ken Friday, Planning Director; and Carolina Rook; BOC Staff. Nohely Barajas-Montalvo participated via Zoom.

E. DEPARTMENT UPDATES:

a. Community Justice – Jessica Beach

Director Jessica Beach answered questions and provided an update to the Board. Some highlights included: the justice reinvestment grant process will be opened for applications on March 31, 2023 and this two-phase process. Director Beach reminded the Board this was a funding source that came into being with the passage of House Bill 3194 in 2013. She explained that the county has been awarded these grant funds for the last 10 years and they currently support the adult pre-trial justice program. She shared that if Senate Bill 5505 passes, these funds will be extended for an additional 10 years through 2034.

Director Beach also provided the adult work crew has seen an increase since the return from Covid, and the juvenile work crew has also seen an increase due to an increase in court referrals. She also shared that the department is working in partnership with the Sheriff's Office in the release of an RFP for new food services.

Michael Firestone. Commissioner Berschauer disclosed a family relation to Michael Firestone and asked that his appointment be removed from the vote. Commissioner Johnston modified his motion to remove Michael Firestone and restated his motion as amended. The motion passed, Commissioners Berschauer, Johnston, and Starrett voting aye.

Commissioner Johnston moved approval to appoint Michael Firestone to the Parks Advisory Board. Commissioner Berschauer abstained from the vote. Commissioner Johnston called for the vote. The motion passed, Commissioners Johnston and Starrett voting aye.
