Pursuant to its Grant Agreement no. 34779 with ODOT, Yamhill County requests its allocation of federal [Surface Transportation Block Grant](#) (STBG) funds to finance the following transportation project(s) eligible under Oregon Constitution Article IX, Section 3a (the "Project"):

Contract with Sierra Sante Fe Corporation for the Yamhill County 2023 Chip Seal Project. This project scope includes Chip Sealing 12 roads throughout the County. It is estimated to be 20.4 centerline miles of Chip Sealing. These roads were on the Capital Improvement Project (CIP) list approved by the Board of Commissioners on February 2, 2023. (See Exhibit A for more details).

Yamhill County hereby exchanges \$419,004.84 in STBG funds for state funds at a ratio of 90 cents state funds for each dollar of STBG funds exchanged.
