RE: Intent to Award Construction for Pike Road Bridge Replacement

BACKGROUND:

This request for approval for Intent to Award Construction for the "Pike Road Bridge Replacement project. This project scope includes remove and replace with a new vehicular bridge, install new pavement, guard rails, and perform the main bridge demolition and bridge replacement in 2 months. This Capital Improvement Project (CIP) is funded by 100% county funds.

Bids were publicly opened at 2:00 pm on November 15th, 2023, at the Public Works building. Eight bids were received. The apparent low bidder was Lawson Construction from Carlton, Oregon for \$799,500.00.

The Engineer's Estimate for Construction was \$881,963.

STAFF RECOMMENDATION:

Staff is requesting the Board approve Intent to Award for construction of the Pike Road Bridge Replacement Project in the amount of \$799,500.00.

FISCAL IMPACT:

Funds will come out of the Road Fund Capital Contractor Services. This project is included in the current approved 2023-24 budget and will be in the proposed CIP Budget for FY 2024-25.
