

I'm currently serving as a SWAC citizen member, and would like to continue to serve.

I'm concerned about the long range liability and costs to Yamhill County citizens for the maintenance of the closed landfills and eventually Riverbend Landfill. I'm concerned about potential impacts to our water and soil resources from our solid waste policies.

I would like to be able to ask questions of waste industry committee members and county staff, and help influence our approach to solid waste as a committee member.

I have been a member of the "Stop the Dump" Board for over 4 years, formerly known as "Waste Not of Yamhill County".
