

**AMENDMENT No. 6 TO AGREEMENT FOR DOG KENNELING SERVICES
BETWEEN YAMHILL COUNTY SHERIFF'S OFFICE AND HOMEWARD
BOUND PETS HUMANE SOCIETY**

THIS AMENDMENT is made and entered into this 20TH day of JUNE, 2024, by and between YAMHILL COUNTY, a political subdivision of the State of Oregon, acting by and through its Yamhill County Sheriff's Office ("County" or "YCSO"), and **HOMEWARD BOUND PETS HUMANE SOCIETY** (formerly Homeward Bound Pets), an Oregon Nonprofit Corporation with its principal place of business located at 10605 SE Loop Road, McMinnville, OR 97128 ("Contractor"), referred to individually as "Party" and collectively as "Parties".

WHEREAS, The Parties executed a services contract on September 20, 2017, pursuant to Board Order No. 17-375 for dog kenneling services to County (the "Contract"); and

WHEREAS, The Parties previously amended the Contract on June 21, 2018, as Board Order 18-207; amended again on June 28, 2019, as Board Order 19-211; amended again on July 30, 2020, as Board Order 20-245; amended again on July 28, 2022, as Board Order 22-246; and amended again on June 29, 2023 as Board Order 23-252 to extend the contract term period, establish new rate, and modify the number of dedicated kennels and overflow kennels; and

WHEREAS, The Parties now wish to amend the Contract to extend the original contract term period, and now, therefore

THE PARTIES hereby agree to amend the Contract as follows (new language is indicated by **underlined font** and deleted language is indicated by ~~strike-out font~~):

1. The section entitled "Term" in the Contract (BO 17-375) is amended to read as follows:

Term. The Effective Date of this Agreement will be October 1, 2017 or upon the date of signatures by all Parties, whichever is later. This Agreement, unless terminated or renewed as elsewhere provided in the Agreement, shall terminate on ~~June 30, 2018~~ **September 30, 2024**. Should COUNTY not be able to obtain funding approval COUNTY will provide 30 days prior written notice before the termination date or the end of the then current term.

2. The section entitled "**Dedicated Kennels**" in Amendment #5 (BO 23-252) Exhibit A is amended to read as follows:

Yamhill County Sheriff's Office agrees to pay for three contracted kennels per day, whether those kennels are empty or full, during the contract period of ~~July 1, 2023 – June 30, 2024~~ **July 1, 2024 – September 30, 2024**.

3. The section entitled "**Overflow Kennels**" in Amendment #5 (BO 23-252) Exhibit A is amended to read as follows:

Overflow Kennels. YCSO will utilize overflow kennels, as available and needed, during the contract period of ~~July 1, 2023 – June 30, 2024~~ **July 1, 2024 – September 30, 2024**.

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
