Hi Mary and Ken,

Attached is amendment #4 to our agreement with the Oregon Health Authority for the financing of Community Mental Health, Addiction Treatment, Recovery, & Prevention, and Problem Gambling Services (BO 24-29).

Amendment 4 adds \$155,000.00 in funding for Civil Commitment Services (MHS 24), effective from July 1, 2024, through June 30, 2025. This amendment will increase the total amount of funds allocated for this service element from \$190,524.10 to \$345,524.10. This funding is included in our Health and Human Services 2024-2025 Adopted Budget. This additional will allow us to add an additional member to our Crisis team to respond to the needs of our community members. Considering this, we would like to request the following changes to the current position management authority within the HHS Adult Behavioral Health Division (Div. 174):

- Add 1.0 FTE Advanced Practice Behavioral Health Clinician (40626) for a Civil Commitment QMHP.

I recommend the Board approve this amendment as written and approve changes to the current position management authority. Please let me know if you have any questions.
