

**AMENDMENT No. 1 TO  
YAMHILL COUNTY CONTRACT FOR  
CORRECTIONAL HEAL CARE SERVICES**

**B.O. No. 23-315**

**THIS AMENDMENT** is made and entered into this \_\_\_\_\_ day of August, 2024, by and between YAMHILL COUNTY, a political subdivision of the State of Oregon, acting by and through the Sheriff's Office ("County"), and MEDTRUST, LLC, a Texas limited liability company doing business as MedHealth, located at 8610 Broadway Street, Suite 270, San Antonio, Texas 78217 ("Contractor") (collectively, the "Parties").

WHEREAS, The Parties executed an agreement for correctional heal care services on August 10, 2023, via Board Order No. 23-315 (the "Agreement"); and

WHEREAS, The Parties now wish to extend the Agreement an additional two months to allow additional time for the County to complete their procurement process; and now, therefore

THE PARTIES hereby agree to amend the Agreement as follows:

1. The compensation to be paid under the Agreement is amended for the additional two months as follows. Article 8, section 8.0 ANNUAL AMOUNT/MONTHLY PAYMENTS is hereby amended as follows (new language is indicated by underlined font and deleted language is indicated by strike-out font):

In addition to the monthly installment, County agrees to pay an additional \$2,500.00 per month for each of the two additional months to cover certain insurance costs incurred by Contractor arising out of this two month extension.

2. The Term of the Agreement is hereby extended two months from the date of expiration. Article IX, section 9.0, "TERM", is hereby amended as follows (new language is indicated by underlined font and deleted language is indicated by strike-out font):


TERM. The ~~Initial~~ Term of this Agreement shall be from August 27, 2023, to ~~August 26, 2024~~ October 26, 2024 (the "~~Initial Term~~").

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
