WHEREAS, on this ____ day of _____, 1964, the County Court for Yamhill County has met in regular session for the transaction of County business, and has had before it the question of the adoption of a permanent zoning ordinance to take the place of the interim zoning ordinances heretofore enacted as Yamhill County Ordinances Nos. 1, 4, 5 and 6 and it appearing to the Court and the Court finding that heretofore the County Planning Commission has conducted a public hearing on said proposed permanent zoning ordinance, and that said county planning commission more than 10 days prior to said hearing gave advance public notice thereof by publishing the same in a newspaper of general circulation in Yamhill County, Oregon, and it further appearing to the Court and the Court finding that the Yamhill County Planning Commission has recommended the adoption of said permanent zoning ordinance in order to carry out a part of the comprehensive plan for the use of land in Yamhill County, Oregon, and it further appearing that a permanent zoning ordinance is necessary to promote the public health, interest, safety and general welfare of Yamhill County, Oregon, taking into consideration those things designated by O.R.S. 215.055, now, therefore,

THE COUNTY OF YAMHILL ORDAINS AS FOLLOWS:

Section 1. The Interim Zoning ordinances of Yamhill County, Oregon, otherwise known as Yamhill County ordinances Nos. 1, 4, 5 and 6, dated _____, 1961, _____, 1963, as amended by Ordinances Nos. 2, 3, 7, 8 and 9, and _____, 1963, respectively, /which said ordinances all are/by this reference hereby made a part of this ordinance, are

hereby adopted as permanent zoning ordinances for Yamhill County, Oregon.

Section 2. This permanent zoning ordinance shall be applicable to the area described and designated in said ordinances Nos. 1, 4, 5 and 6, ^{as amended,} and the zoning maps attached thereto and made parts thereof, and no structure or lot shall hereafter be used or occupied and no structure or parts thereof shall be erected, moved, reconstructed, extended, enlarged, or altered contrary to the provisions of this ordinance.
