

## AMENDMENT No. 2 TO YAMHILL COUNTY FOR SERVICES

### Contract No. 23-128

**THIS AMENDMENT** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2024, by and between YAMHILL COUNTY, a political subdivision of the State of Oregon, acting by and through its Health and Human Services Department (“County”), and RSS Architecture, P.C. of 2225 County Club Road, Woodburn OR 97071 (“Consultant”).

The parties executed a services contract on April 7, 2023 (the “Underlying Agreement”), pursuant to Board Order No. 23-128. The Underlying Agreement was first amended on January 26, 2024 (“First Amendment”). The parties now hereby agree to further amend Underlying Agreement as follows:

1. The section entitled “Term” is amended to read as follows (additions are underlined and deletions are in strike-out):

“TERM. This Contract shall become effective, and services required hereunder shall commence on the date the Contract is executed by both parties and shall terminate on ~~December 31, 2023, June 30, 2024,~~ December 31, 2024, unless otherwise terminated or extended as provided herein.”

2. The section entitled “Consideration” subsection a. is amended to read as follows (additions are underlined and deletions are in strike-out):

“CONSIDERATION,

- a. Not-to-Exceed. As consideration for the performance of all terms and conditions set forth in this Contract, the County shall pay the Consultant a sum not to exceed ~~\$42,500.00~~ \$47,000.00. Payment for all services performed hereunder, including reimbursable expenses as provided below shall not exceed this amount.”

3. The section entitled “Exhibit A” subsection 4 is amended to read as follows (additions are underlined and deletions are in strike-out):

“4. Total proposed fixed design consulting services for Architectural and sub-consultant professional design consulting services based on project assumptions listed above =

~~\$40,000.00~~ \$44,500.00”

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Consultant certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
