6 THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON
7 (the Board) on the 8th day of December, 1982 sat for the
8 transaction of County business in regular session, Commissioners
9 TED LOPUSZYNSKI, ROBIN J. HAMBLET and COLIN ARMSTRONG being
10 present.

11 WHEREAS, the Board, recognizing that ORS Chapter 203,
12 regulating the transaction of County business, created more
13 questions that it answers regarding the procedures to be utilized
14 by the Board in the conduct of meetings; and

15 WHEREAS, the Board, in order to remedy this situation
16 adopted Ordinance No. 284, which governs procedure used in the
17 conduct of Board meetings; and

18 WHEREAS, even after the adoption of Ordinance No. 284,
19 questions occasionally arise as to whether the procedures contained
20 in ORS 203 apply to the adoption of Ordinances; and

21 WHEREAS, a question has arisen as to whether Yamhill County
22 has an ordinance which provides for the manner of enacting, amending
23 or repealing Orders, Resolutions, and Ordinances; and

1 WHEREAS, the Board believes that it is in the best interests
2 of the citizens of Yamhill County to clarify these procedures and to
3 establish uniformity in regard to the manner of enacting, amending,
4 or repealing Orders, Resolutions, or Ordinances; and

5 WHEREAS, it is the intent of the Board by this Ordinance
6 to amend Ordinance NO. 284 by adding the language ordained herein,
7 while preserving Ordinance No. 284 in full force and effect;

8 NOW, THEREFORE,

9 THE BOARD OF COMMISSIONERS FOR THE COUNTY OF YAMHILL
10 ORDAINS AS FOLLOWS:

11 That Ordinance No. 284 is hereby amended by
12 adding the following language:

13 PROCEDURE FOR ADOPTING ORDERS, RESOLUTIONS, AND ORDINANCES

14 Orders and Resolutions shall be adopted by the Board at
15 Board meetings in accordance with applicable law. Repeal or amendment
16 of an Order or Resolution shall be accomplished by subsequent Order
17 or Resolution.

18 The procedure for adopting Ordinance as provided in
19 ORS 203.045 shall apply to all Ordinances adopted by the Board unless
20 another procedure is authorized by law. Repeal or amendment of an
21 Ordinance shall be accomplished by subsequent Ordinance adopted in
22 compliance with this section.

23 This Ordinance being necessary for the health, safety and
24 welfare of the citizens of Yamhill County and an emergency having
25 been declared to exist, shall be effective upon the passage hereof.
