THE BOARD OF COMMISSIONERS OF YAMHILL COUNTY, OREGON (the Board), on the 29th day of June, 1983, sat for the transaction of County business, in special session, Commissioners Robin J. Hamblet and Dave Bishop being present.

WHEREAS, the Board on March 30, 1983, enacted Ordinance 333 entitled "In the Matter of an Ordinance to Amend the Yamhill County Comprehensive Plan of 1974 for Property Known as the Stell-flug Property"; and

WHEREAS, in said Ordinance 333, the subject property was identified as Yamhill County Tax Lots 3529-400 and 3532-400, when in actuality the subject property is properly identified as Tax Lots 2529-400 and 2532-400; and

WHEREAS, the above-described error was inadvertant and constituted a typographical error which may be summarily corrected by an amendment to Ordinance 333; and

WHEREAS, no rights are prejudiced by the correction of these typographical errors without a formal public hearing; NOW, THEREFORE,

IT IS HEREBY ORDAINED that Ordinance 333 be and hereby is amended as follows:

Section 1. Lines 8 and 9 of paragraph 3 of Ordinance 333 shall be amended to read "particularly described as Yamhill County Tax Lot 2529-400 and 2532-400, and".

Section 2. Lines 3-6 of paragraph 6 of Ordinance 333 shall be amended to read "the 5 acre portion of Tax Lot 2532-400 as shown on the sketch plan attached hereto as Exhibit 'B' and by this reference made a part hereof, as 'Recreation Commercial' and the 52 acre portion of Tax Lots 2532-400 and 2529-400 as 'Parks, Recreation and Open Space'."


This Ordinance being necessary for the health, safety and welfare of the citizens of Yamhill County, and an emergency having been declared, shall be effective upon passage hereof.
