

**AMENDMENT No. 4 TO YAMHILL COUNTY AGREEMENT FOR
FOR PARENT COACHING & SCHOOL BASED BEHAVIORAL HEALTH SERVICES
LUTHERAN COMMUNITY SERVICES NORTHWEST**

Contract No. HHS24015GS (BO 21-281)

THIS AMENDMENT is made and entered into this 1st day of May, 2025, by and between the YAMHILL COUNTY, a political subdivision of the State of Oregon, acting by and through its Health and Human Services Department (“County”) and **Lutheran Community Services Northwest**, an Oregon nonprofit corporation, (**LCSNW**), of 435 NE Evans St. Ste. A, McMinnville, Oregon 972128 (“Contractor”) (collectively, the “Parties”).

WHEREAS, The Parties executed a services contract on July 8, 2021, pursuant to Board Order No. 21-281 for Parent Coaching & School Based Behavioral Health Services (the “Contract”); and

WHEREAS, The Parties previously amended the Contract on July 7, 2022, pursuant to Board Order No. 22-213 to amend Reporting and Compensation sections; and

WHEREAS, The Parties previously amended the Contract on February 14, 2024, pursuant to Board Order No. 24-30 to amend the Compensation section; and

WHEREAS, The Parties previously amended the Contract on June 27, 2024, pursuant to Board Order No. 24-181 to amend the Compensation section; and

WHEREAS, The Parties now wish to amend the Contract to amend the Compensation section; and now, therefore

THE PARTIES hereby agree to amend the Contract as follows (new language is indicated by underlined font and deleted language is indicated by strike-out font):

1. The section entitled “Compensation for Services” is amended to read as follows:

“**Compensation for Services.** As compensation for performing the Services, following receipt and approval of billing documents, Contractor shall receive a payment of ~~\$15,501.04~~ ~~\$16,276.10~~ \$17,089.90 per month for providing Transitional Treatment and Recovery Support Parent Coaching services and ~~\$34,961.47~~ ~~\$36,709.55~~ \$44,173.40 per month for providing School Services for ~~3.08~~ 3.58 FTE (full time equivalent) Qualified Mental Health Professional (QMHP) and .5 FTE Qualified Mental Health Associate effective July 1, ~~2023~~ ~~2024~~ 2025. The maximum amount payable for performance of Services under this Agreement is ~~\$605,550.12~~ ~~\$635,827.80~~ \$735,159.60 per year.”

Except as expressly amended above, all other terms and conditions of the original contract are still in full force and effect. The Contractor certifies that the representations, warranties, and certifications contained in the original contract are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
