**VOTER REGISTRATION INFORMATION**

To be eligible to vote in the November 8, 2011, election, a completed voter registration card must be on file with the Yamhill County Clerk by not later than 5:00 p.m., October 18, 2011.

**YOU MAY REGISTER TO VOTE IF:**

- You are a citizen of the United States.
- You will be 18 years of age or older on election day.
- You are a resident of Oregon.

**YOU MUST REREGISTER TO VOTE IF:**

- Your residence or mailing address changes.
- Your name changes.
- You wish to change party affiliation.

**VOTING INSTRUCTIONS**

When you get your ballot packet in the mail after October 21, 2011, immediately examine it to make certain it is complete. It should contain the following items:

- A printed ballot on which you may vote your choice;
- A secrecy envelope with voting instructions printed on it;
- A pre-addressed blue trimmed return envelope in which to return your ballot;
- This Yamhill County Voters' Pamphlet.

If any items are missing, contact the Yamhill County Clerk's Office, at 503-434-7518 or 503-554-7850 from Newberg, and a replacement ballot packet will be sent to you.

**VOTING YOUR BALLOT**

To vote "yes" or "no" on a measure, with a blue or black pen simply fill-in the box next to the vote of your choice.

If you make an error on your ballot, spoil it in any way or lose it, you may obtain a replacement ballot by contacting the Yamhill County Clerk's Office at 503-434-7518 or 503-554-7850.

**RETURNING YOUR VOTED BALLOT**

- Follow the instructions on the secrecy envelope.
- Fold your ballot along the pre-scored fold and insert it into the secrecy envelope.
- SEAL the return envelope and SIGN the statement on the back of the envelope. Your ballot will not be counted if your envelope is not signed.

The Newberg annual budget is already \$70 million but they want more and will just take it! But if the city provides adequate justification for new taxes, probably none would object.

For example, at the Aug. 1 council work session, the city manager proposed new revenue from a GAS tax or a transportation impact fee assessed against your house or business and placed on the water bill.

Many of us are out of work, face foreclosure or eviction, and can't afford new fees. Yet without Measure 36-149, we cannot stop these fees since NO number of taxpayers can refer a tax to the ballot when the tax is renamed a "fee".

Without Measure 36-149 we are helpless to enforce our authority under the Oregon Constitution. **Take back control of your hard-earned money.**

As your elected city representatives we welcome and encourage citizen involvement. Because of this belief, Newberg has set up a process to review proposed tax and fee increases.

Any proposed increase is reviewed publically and evaluated by a seven-member Citizen Rate Review Committee and public recommendations are given to the City Council for further review and deliberation.

If citizens of Newberg are not happy with the decisions of the 7 member citizen review panel and the vote of the 7 members of the City Council, then, as provided in Oregon law, 10% of the city can challenge any legislation and that issue will go to a special election.

**Newberg's current process works.** Newberg's City Charter (Newberg's Constitution), was passed by 7 out of 10 voters.

This measure would undermine a citizen driven process that is open to the public and is fiscally responsible.

36-149 would allow as few as five people to prompt a special election. Special elections are expensive. It can cost tax payers \$10,000 - - just to print, mail, and count the ballots.

Additionally, there are other costs as well: litigation to resolve conflicts in the initiative with state law and the possibility of damage to the city's credit rating resulting in higher interest rates on city projects.

It is our fear that if 36-149 were to pass, money would be wasted on special elections and lawsuits rather than going towards necessary infrastructure projects.

In the city of Sheridan, where they passed a similar measure, it has cost them \$30,000 just in lawsuits alone.

Vote **NO** to protect our citizen review panel and to prevent money from being wasted on special elections and lawsuits.

**SENIOR CITIZENS RESPONSE TO BALLOT MEASURE 36-149  
(The Tax and Fee Responsibility Amendment))**

The citizens of Newberg need to look closely at Measure 36-149 because it will change Newberg and how we conduct business as a city. This measure can require us to hold special elections on every little increase in taxes, fees and other charges, even the ordinary things most people never even think about.

Currently, in addition to electing our city officials to review needed changes, we have a **Citizen Rate Review Committee**, selected from Newberg residents, to review any proposed city fees and make recommendations to the city council. The public always has input in these reviews and the recommendations are on the public record so elected official can be held responsible.

Today, if 10% of Newberg citizens are concerned over a measure passed by the city council, they can petition the city to hold a special election. If 10% don't support the petition, it probably would not pass anyway.

**Passage of Measure 36-149 will allow any 5 people in the city of Newberg to force an election, and the entire community will have to pay for the cost.**

Special elections are important but they should be reserved for important issues that concern the overall community. We can't afford an election for every minor fee adjustment. **These elections will cost us thousands of dollars and need to be reserved for major decisions.**

**"If it's not broke, don't fix it,"** are words people live by, and now is a good time to remember them.
